Message From the President

On behalf of the board of directors, it is my distinct honor to present to you the 1998 annual report for the Fay-Penn Economic Development Council. This report to the community details the accomplishments of the organization involving many companies and projects that will further enhance Fayette County's ability to grow economically for many years into the future. All of the achievements described in the annual report could not have been realized without the support and encouragement of the general membership and the cooperation of many other organizations working together to move Fayette County Forward.

In 1998, Fay-Penn assisted 18 companies in making over \$2.4 million in new capital investment. These companies project to generate or retain 219 jobs. In total, since 1992, Fay-Penn has assisted 90 companies in 109 different economic development projects involving more than 3,500 jobs.

The cumulative results of our efforts are having a profound impact on our community. Last year, Fayette County's unemployment rate dropped to its lowest rate in 25 years. The total investment from these projects exceeds \$10.5 million. Despite these accomplishments, a 7.2% unemployment rate is still too high. With a robust national economy, there is a great opportunity for us to further reduce our unemployment rate by capitalizing on the investments that we have and are continuing to make in Fayette County.

The ground work has been laid for establishing new tax free zones which will provide an unprecedented economic incentive for companies to expand in our area. However, competition between states for companies and jobs continues to escalate making our task even more challenging. Tax free zones alone will not be enough to meet our job growth expectations. We need to continue to make investments in new sites and in our work force to create an environment that is attractive to businesses. This year, a major section of the Mon-Fayette Expressway will open, greatly improving our transportation system. But without ready-to-move into sites with water, sewer, gas, electric, and telecommunication utilities needed for businesses to operate, we will experience very little positive economic impact from this \$100 million investment.

Last year as in previous years, significant progress was made and results were achieved, but major challenges still remain. From site development to marketing to job training, there is a great deal that needs to be done. The board of directors and general membership along with our affiliated organizations are committed to doing everything that they can to continue to make a positive difference in the lives of the residents of our community. With everyone's continued support, the next five years in Fayette County will prove to be one of the most exciting times in our history.

Overview

The Mission

Fav-Penn@ mission is to maintain and increase employment opportunities (jobs) in Fayette County in an effort to improve the quality of life for all of its residents. This mission is met through a comprehensive strategy of specific economic development objectives and by providing superior services to its clients. The organization primarily focuses on the manufacturing sector in addition to a concentration on tourism and *infrastructure* development. The objectives and strategies listed below summarize initiatives in which Fay-Penn is involved and do not include many action items contained in the *more* comprehensive **Favette County** Strategic Plan - Fayette Forward.

Incorporated in 1991, Fay-Penn was formed to assist in the economic revitalization efforts of Fayette County. The organization was designated by the Internal Revenue Service (IRS) as a tax-exempt, nonprofit organization under Section 501(c)(3) of the Internal Revenue Code. As a membership based organization with over aprox. 200 members, funding comes from various local, public, and private contributors and foundations, in addition to grant support from the Commonwealth of Pennsylvania and federal government for specific projects. Funds may not be used for the benefit of or be distributed to members, directors, officers, or private persons. All contributions are used to support the economic development revitalization efforts including providing administrative assistance for other economic development organizations and initiatives.

Provide superior economic development services that meet the needs of Fayette County by building local capacity and capabilities.

- Develop the organization and resources needed to provide top quality, professional economic development services and programs through a strong public and private partnership.
- Building linkages with the Pittsburgh business and economic development community to increase the use of programs and other resources that can support local efforts and strengthen business activity in both Fayette County and the southwestern Pennsylvania region.
- Establish a business assistance network that offers a full range of support services for business and local government.
- Conduct the "Team PA" outreach to businesses throughout Fayette County to offer assistance as part of an aggressive business retention and expansion effort.

Expand tourism in Fayette County to generate new commerce and jobs, revitalize commercial areas and support new development.

- Advance the tourist industry of Fayette County and the Laurel Highlands from a weekend mountain recreation area to a fullservice, multi-day vacation destination.
- Serve as a catalyst to develop multi-day tourism packages by building thematic linkages between individual attractions in an effort to increase weekday tourism.
- Assist local businesses in transitioning to better capitalize on growth opportunities presented in a dual manufacturing and tourism based economy.
- Build linkages with local, regional and state organizations, and the private business sector to develop the resources needed to implement a comprehensive tourism development strategy.
- Assist local historical societies, businesses, and community development organizations in their efforts to develop new tourism attractions and renovate downtown areas throughout Fayette County.

Provide services to ensure that Fayette County has a qualified workforce to accommodate worldclass industry.

- Serve as a facilitator for companies to coordinate workforce delivery system services.
- Increase the use of existing programs by companies and assist in securing available job training funds.
- Support the development of employer driven workforce training programs.
- Encourage educational initiatives that address the current needs of businesses.

Encourage development at existing and future business sites.

- Concentrate marketing on vacant buildings and available land in business parks.
- Expand infrastructure capabilities at existing and future development sites.
- Improve road, air and rail transportation systems including maintaining rail service in Fayette County for existing and future rail users.
- Develop new tax free sites through improved planning, marketing and financing techniques.

Business

Services

Financing Assistance:

A variety of low-interest financing programs are available for companies in Fayette County through the Pennsylvania Department of Community and Economic Development (PA DCED). Funds may be used for land, buildings, equipment, working capital, and job training. Fay-Penn's staff works hands-on with each company guiding them through the necessary procedures and coordinating efforts with the company's private lending institution. Other funds are available through various financing programs. The Fay-Penn staff knows which programs can be used to fit a company's specific needs.

Business Technical Assistance:

Fay-Penn, with the support of a regional and state economic development team, under the "Team PA" umbrella, offers technical assistance to businesses of all types and sizes throughout the County. The staff will do whatever is possible to assist companies in meeting their needs and accommodating their business development projects. This includes areas of financing, marketing, process improvement, government procurement, exporting, quality improvement, as well as others.

Site Selection:

Current listings of available sites or buildings are maintained by Fay-Penn and are provided to companies looking for new locations. The staff works closely with the Governor's Action Team and Penn's Southwest Association on potential projects and networks with realtors and property owners to keep abreast of the industrial real estate market. Site proposals are prepared with current market, utility and quality of life information.

Tourism Development:

Fay-Penn is working with businesses, historical societies, Fayette Forward and other agencies to develop the tourism industry in Fayette County beyond its already wonderful array of visitor-ready sites and attractions. Assisting to develop new businesses, attractions, community projects, and increasing tourism packaging efforts are all part of the initiatives to help the Fayette County tourism industry grow.



Fay-Penn offers a full range of confidential services and works very closely with each client to provide customized service and maintain confidentiality.

Loan Funds:

Fay-Penn administers a \$4.34 million loan fund to assist qualified businesses with financing. Low interest loans of up to \$375,000 can be made. Specific guidelines have been developed and approved by the PA DCED to determine the project eligibility. For very small businesses, Fayette County entrepreneurs can turn to the Small Business Administration Microloan Program for assistance.

Business Park Development:

The location of new and expanding businesses and related infrastructure development is an important function of Fay-Penn. Working with the Fayette Industrial Fund, Connellsville Industrial Enterprises, the Redevelopment Authority of the County of Fayette, and local municipal authorities, the Fay-Penn staff acquires and develops new land and infrastructure with special focus on industrial and business parks in the county.

Small Business Technical Assistance:

Fay-Penn's Small Business Technical Assistance Resource Center provides hands-on assistance to start-up and existing businesses with writing business plans. Service is provided on a private, individual basis, in an effort to secure loan financing and to improve business success. The Small Business Technical Assistance Resource Center also participates in conducting small business seminars to ensure entrepreneurs an opportunity to keep abreast of the latest, up-to-date small business issues.

Workforce Development Assistance:

Fay-Penn's Workforce Development Specialist provides services that address the job training needs of both the workforce and local businesses. The staff also coordinates meetings for local companies with experts from other regional economic development organizations specializing in workforce training, ISO 9000 standards and other worldclass, quality training.







Business Development

Wilhelm and Kruse, Inc.

Wilhelm and Kruse, Inc., a leader in the metal fabricating industry, purchased the vacant HBC Barge facility in Brownsville, PA. Fay-Penn assisted Wilhelm and Kruse in the financing of the acquisition and renovation project utilizing a \$420,250 Pennsylvania Industrial Development Authority Ioan and a \$200,000 Ioan from Fay-Penn's Ioan fund. The company also used tax-exempt bond financing through the Fayette County Industrial Development Authority to finance the balance of the project. Not only will this expansion project result in the creation of forty (40) new jobs at the facility, it will also reuse a facility abandoned over three years ago in one of the most distressed areas of Fayette County.

Laurel Machine Company, Inc.

In 1994, Laurel Machine Company, Inc. constructed a new manufacturing facility in Mt. Braddock. During 1998 Laurel Machine undertook a second expansion to the facility. Fay-Penn assisted in this expansion project with a \$55,000 loan through the Fay-Penn Revolving Loan Fund (\$25,000 of the loan came from the Fay-Penn Enterprise Zone Loan Fund.)



Laurel Machine expects this expansion project to result in the creation of four (4) new jobs at the facility.

Dynamic Materials Corp. (DMC)

DMC, headquartered near Boulder, Colorado, began construction of a 54,250 sq. ft. manufacturing facility in the Greater Uniontown Business Park. The company currently bonds dissimilar metals using explosives at a local mine three (3) miles away, near Dunbar. Fay-Penn spearheaded the project with the Governor's Action Team helping to secure various state grants and tax-credits from the Commonwealth, including a \$150,000 Opportunity Fund Grant, \$150,000 Customized Job Training Grant, \$23,500 Rail Freight Assistance Grant, and \$250,000 in tax credits through the State's Enterprise Zone Program. The project is expected to create 125 new jobs within the next three (3) years.

TeleTech Customer Care Management (PA)

Highlighting the end of 1997 was the announcement that TeleTech Holdings, Inc. will locate a customer service call center in Fayette County. To assist with leasehold improvements and for the purchase of furniture and equipment for the facility, Fay-Penn approved a \$375,000 loan through the Fay-Penn Revolving Loan Fund. In operation since February, the company has already created the 600 jobs expected from this project when it was announced in 1997.

Berkley Surgical Corporation

Berkley Surgical Corporation has been located in Fayette County since 1987. This diverse manufacturing company deals in specialty non-wovens for the medical, industrial, and food service industries. A \$55,000 loan through the Fay-Penn Revolving Loan Fund, was approved to assist with the purchase of machinery and equipment and for manufacturing facility renovations. This expansion project expects to create five (5) new jobs at Berkley Surgical Corporation.

C.F.R. Acquisitions, Inc.

The purchase of two carbon material reclamation businesses in Fayette County was completed by C.F.R. Acquisitions, Inc. in 1997. At that time, a \$250,000 application was submitted to the Commonwealth of Pennsylvania Enterprise Zone Competitive Grant Program to assist with the financing of the project. In November, 1998 the application was approved and the funds were loaned to the company through the Fay-Penn Enterprise Zone Loan Fund. These funds were used to reduce the original bank debt in the project. Fifty-six (56) existing jobs were retained at the two companies purchased through this financing assistance.

EZ Welding and Fabrication

EZ Welding and Fabrication provides its customers with all types of steel and aluminum supplies, structural steel fabrication and commercial railing. The company needed to purchase machinery and equipment to address increased sales. A \$40,000 loan through Fay-Penn's Revolving Loan Fund was used to assist with the financing of this purchase. Two (2) new jobs will be created as a result of this expansion project.

Nu-Metrics, Inc.

Nu-Metrics, Inc. constructed a 20,000-sq. ft. manufacturing and administration facility in Mt. Braddock in 1995. Continued sales growth over the past three years resulted in the need to expand the facility for additional manufacturing and warehouse space. In 1998 a 6,200 sq. ft. addition was completed. A \$175,000 loan through the Fay-Penn Revolving Loan Fund assisted with the financing for this expansion project. Nu-Metrics, Inc. expects to create fifteen (15) new jobs as a result of this project.

Houze Glass Inc.

Houze Glass Inc. has been growing consistently since the purchase of the company in 1994 by the current owners. Over the past two

years, Houze Glass Inc. has tripled its product line, increased sales, and now offers nationwide distribution through two affiliates. To help finance working capital needs associated with this growth, Houze Glass Inc. was assisted through the Fay-Penn Loan Guarantee Program with a \$100,000 pledge against a revolving bank credit note.

LenoraÕ, Inc.

The first capital expansion project to be financed through the newly established Fay-Penn Tourism Revolving Loan Fund Program was an 12-room country inn to be constructed by Lenora's, Inc. Lenora's, Inc. received a \$40,000 loan from Fay-Penn to assist with construction of the Inn, purchase of furniture and fixtures, and working capital. A \$100,000 loan through The Progress Fund, a regional tourism loan program, was also used to finance this project. This project will create four (4) new tourism related jobs in Fayette County. In addition to coordinating financing assistance, Fay-Penn also provided technical assistance through its Small Business Development Program. George R. Smalley Company Reed Tool & Die, Inc. A&I Sales





George R. Smalley Company

George R. Smalley Company, an industrial electrical systems contractor, has experienced significant sales growth since it was established in 1958. Continually expanding its services and service area, the company was in need of additional space for its operations and warehouse area. A \$32,500 loan through the Fay-Penn Revolving Loan Fund assisted with the construction of a 4,800 sq. ft. facility addition. This expansion project will result in the creation of three (3) new jobs.

Reed Tool & Die, Inc.

Reed Tool & Die, Inc. recently underwent its second business expansion project within the last four years. An \$85,000 loan through the Fay-Penn Revolving Loan Fund assisted with the purchase of machinery and equipment another \$105,000 loan was made to John & Minnie Reed to expand the manufacturing facility. Reed Tool & Die, Inc., a manufacturer specializing in made-to-order high speed or carbide cutting tools, expects to create ten (10) new jobs as a result of this expansion project.

A&I Sales

A&I Sales, established in 1979, sells industrial air filter products and Ansul Fire Extinguisher Systems throughout the tri-state area. In addition to providing small business technical assistance, Fay-Penn assisted A&I Sales with a \$35,000 loan through the Fay-Penn Revolving Loan Fund for the purchase and renovation of an office/warehouse facility in a highly visible site in the City of Uniontown. Participation in this project will help retain the three (3) existing jobs.

Small Business Development

During 1998, the Small Business Development Program at Fay-Penn received 240 inquiries from individuals, entrepreneurs and small companies. Thirteen (13) of these businesses received technical assistance, with seven (7) additional businesses securing financing in the amount of \$526,405. As a result, 15 jobs were created and/or retained. The companies that have invested in Fayette County include, but are not limited to, Sew Special, Little Moe Crown & Bridge, Prescription Solutions, and Terri's New Image Salon. Fay-Penn also continues to provide monthly new business workshops for those wanting to learn more about starting and growing a business.

SBA Microloan

The Small Business Administration Microloan Program continues to provide an alternative source of financing to small business owners. The



program was established in 1993 as a cooperative effort among Fay-Penn Economic Development Council, Washington County Council on Economic Development, and Greene County. It was expanded to include the Westmoreland Economic Development Corporation, the Morgantown Area Economic Partnership, the Monongalia County Development Authority, and the Preston County Economic Development Authority. In 1998, three (3) Fayette County businesses secured financing bringing the total financing to \$275,420 through loans made since the inception of the program. This program has allowed a total of 17 businesses to invest in the community.

Underground Storage Tanks

December 22, 1998 marked the date that owners of regulated underground storage tanks (USTs) needed to have their tanks in compliance with new Federal Environmental Protection Agency regulations. To assist tank owners in upgrading equipment to meet these requirements, the Commonwealth of Pennsylvania established the Underground Storage Tank Indemnification Upgrade Loan Program. This is a low-interest loan program that provides funding for activities necessary to bring regulated USTs into compliance. Fay-Penn assisted tank owners in preparing the loan applications and necessary documentation. Fay-Penn is currently working with six (6) tank owners to assist them in obtaining loans to upgrade their equipment and continue operating their businesses.



Fay-Penn Revolving Loan Fund

Originally established in 1993, Fay-Penn has successfully added new programs within the \$4.34 million Revolving Loan Fund (RLF). The Fay-Cap Loan Fund, Enterprise Zone Loan Fund (EZLF), and Fayette County Commissioners Loan Fund (FCCLF) Programs assist eligible businesses by funding capital expansion projects involving fixed assets, such as new equipment and facilities at low interest rates. The Loan Guarantee Program (LGP) can guarantee a percentage of private lending institution loans to eligible companies. The goal of the fund is to encourage job growth in the private sector. To date, 40 projects have been financed through the program resulting in over \$22 million in private investment and the potential creation and/or retention of over 1,300 jobs. During 1998 the fund grew from \$3.66 million to \$4.34 million thanks to the Enterprise Zone Grants and a Community Revitalization Assistance Program Grant secured with the support of the Fayette County Board of Commissioners and the Fayette County Legislative Delegation. In 1998, thirteen loans were made through the Revolving Loan Fund. These projects resulted in the creation and/or retention of 686 jobs. The RLF programs have proven to be an important funding tool to help companies make new capital investment in Fayette County.

Tourism Revolving Loan Fund

Fayette County's economy has benefited immensely over the years from income generated through the tourism industry. Fayette County has abundant outdoor recreational opportunities and tourism and cultural attractions. Building upon these quality of life strengths will help support other business development efforts. In 1998, Fay-Penn established the Tourism Revolving Loan Fund (TRLF) Program, designed to encourage tourism commerce development in Favette County. Applicants to the TRLF Program must provide evidence that revenues generated are derived from tourism activity. Unrestricted funds were transferred from the Fay-Cap Loan Fund account to establish the Tourism Revolving Loan Fund Program.

Enterprise Zone Loan Fund

After a successful effort by Fay-Penn, with the support of the Pennsylvania Department of Community and Economic Development, parts of Fayette County were designated as a state Enterprise Zone for the 1st time since 1996. In 1997, the Enterprise Zone Loan Fund was established within Fay-Penn's Revolving Loan Fund (RLF) Program to administer grants received by Fayette County from the Pennsylvania Departments of Community and Economic Development Enterprise Zone Program. With the support of the Fayette County Board of Commissioners, \$525,000 was secured through the Enterprise Zone Program in 1998. Projects eligible to access these loan funds must be located within the designated Fayette County Enterprise Zone. During 1998, funds were secured for loans to C.F.R. Acquisitions, Inc., Laurel Machine Company and Fay-Penn's 32,400 sq.ft. multitenant project. These projects will result in the creation/ retention of 110 jobs. As the loans are repaid, the funds will be used to recapitalize the Fay-Penn RLF for use by other companies located in the Fayette County Enterprise Zone.

Community Revitalization Assistance Program Grant

During 1998, Fay-Penn contracted with the Pennsylvania Department of Community and Economic Development to received a \$150,000 Community Revitalization Assistance Program Grant from thanks to the efforts of Fayette County's State Legislative Team in Harrisburg. The grant funds was used to capitalize the Fay-Penn Revolving Loan Fund.

Fay-Penn's Multi-Tenant Facilities Favette Business Park

During 1998, Fay-Penn completed construction of Phase I of a new 32,400 sq. ft. multi-tenant building located in the Fayette Business Park. Fay-Penn's Board of Directors authorized this second multi-tenant building in an effort to address the ongoing need for quality, readily available building space. This new facility, located directly adjacent to Fay-Penn's first multi-tenant building, can house up to six occupants with the potential for an estimated 50 new jobs at the site. In March 1998, Fay-Penn completed the

acquisition of a 115,000 sq. ft. vacant manufacturing facility in North Union Township. During 1999, the facility will undergo extensive renovations and improvements to transform the facility into a multi-tenant building. Once renovations are completed, the facility can house up to six occupants with a potential for an estimated 150 jobs at the site. The multi-tenant projects were made possible by financial contributions from the Eberly Foundation.

Industrial Park Development

In an effort to increase the number of available sites for potential business expansion/location projects, and to generate economic development activity in many of Fayette County's most distressed communities, Fay-Penn invested, financed or committed up to approximately \$4.3 million to acquire vacant properties for development as future business parks. Until now, except for the remaining 150 acres in the Fayette Business Park, there was virtually no significant acreage available in the five (5) existing

Industrial Park Marketing

Fay-Penn provides ongoing assistance to Fayette Industrial Fund, Connellsville Industrial Enterprises, and the Fayette County Redevelopment Authority by marketing their respective industrial park sites to potential businesses. Fay-Penn regularly develops and provides customized site proposal packages, brochures, maps, photos, demographic information, etc. to each individual business looking for potential sites in the Fayette County area. In addition, Fay-Penn maintains a listing of vacant buildings and available sites for industrial and commercial development.

business parks in Fayette County. The majority of the existing parks are nearly filled to capacity. Fay-Penn acquired an additional 700 acres of land from local property owners at various locations along the Route 119



Fayette Enterprise Community (FEC) Federal Designation

Fay-Penn invested hundreds of hours of time to lead a successful county-wide effort to receive Federal Enterprise Community status as a result, Fayette County was granted this significant national designation by the President's Community Empowerment Board, chaired by Vice President Al Gore. Six (6) census tracts and three (3) development sites in Fayette County have received the federal government's attention through its recent designation as a Rural Federal Enterprise Community. Part of an elite, national group of approximately 60 acres, federal empowerment zones and enterprise communities will receive special funding consideration and the potential for significant set-aside funding from virtually all of the federal departments, such as: education, agriculture, housing, economic development, etc. The purpose of the program is to provide distressed communities with the tools necessary for the residents of those communities to empower themselves through a strategic plan and implementation process. Fayette County was successful in winning one of twenty designations, during a national competition of approximately 160 applicants thanks to the efforts of our local, state and federal elected officials, Fayette Forward, and the

following organizations that worked to develop the application: Connellsville Redevelopment Authority, Fayette County Community Action Agency, Inc., Fayette County Office of Community and Economic Development, Fayette County



Redevelopment Authority,

Uniontown Business District Athority and Uniontown Redevelopment Authority. Fay-Penn will serve as the responsible administering agency for the program.

Fayette County Enterprise Zone

Now in its third year, the Fayette County Enterprise Zone designation by the Commonwealth of Pennsylvania has been a valuable tool to the county's economic development efforts. Administered by Fay-Penn, the Fayette County Enterprise Zone designation gives projects located within the 14 municipality designated area priority consideration when applying for assistance under state programs. The Zone spans from the Westmoreland County border to Smithfield Borough, following the Route 119/Southwest Pennsylvania Railroad corridor. In 1998, businesses in Fayette County received \$580,000 in Enterprise Zone funding, raising the total funds received to \$780,000 since inception in 1996. The funds were loaned through Fay-Penn to companies located within the Fayette County Enterprise Zone for job creation and retention projects.

Keystone Opportunity Zone (KOZ) Designation

Feb. 25, 1999 was an exciting day for Fayette County. Gov. Tom Ridge announced the state's 12 new Keystone Opportunity Zones (KOZs) - where state and local taxes will be eliminated to stimulate job creation and community renewal in some of Pennsylvania's most challenged communities. Fayette County received approval for KOZ designation for approximately 3,000 acres. The acreage is comprised of several different sites located throughout Fayette County. The Fayette County sites were included in a

regional application representing six other southwestern Pennsylvania counties, coordinated by Southwestern Pennsylvania



Commission. Businesses located in the Fayette County KOZ sites will not have to pay state corporate net income, capital stock and franchise, state sales, local real estate, net profits, and business gross receipts taxes through December 31, 2010. This is a true example of public/private partnerships. Much of the credit for the success of the KOZ designation belongs to our state and local elected officials and local school boards. Through their strong commitment and financial support of the KOZ program, these progressive leaders have illustrated a true desire to see their communities' progress into the next millennium. In addition to property owned by Connellsville Industrial Enterprises, Fayette Industrial Fund, South Union Township, and Fayette County, Fay-Penn invested, financed or committed to approximately \$4.3 million in the KOZ program by purchasing additional land to maximize the amount of tax-free acreage for inclusion as KOZ sites. Fay-Penn would not have been able to afford the investment without the support of Robert E. Eberly, who personally guaranteed a portion of the financing for the KOZ properties.



Workforce Development

Workforce quality and technical proficiency are critical issues for today's companies and are critical issues for any communities economic vitality. In 1998, with the assistance of an Appalachian Regional Commission grant, Fay-Penn was able to sponsor training for thirty-five companies who met the small business criteria. This effort supports our mission to develop employer led workforce training programs. 1998 was also the year that the Human Resource (HR) Network was established. The purpose of the HR Network is to bring together business owners and human resource professionals, identify issues, and prioritize needs, then provide the resources that meet those needs. A local wage and salary survey was also completed in 1998. Fay-Penn works continuously with companies providing technical assistance in the area workforce data, labor market information, education and training resources, and coordinates workforce delivery system services. Providing useful information to both local companies and companies evaluating the area.

Information/Training: The Key to Success

In an effort to support local business needs, Fay-Penn cosponsored several information, training and networking seminars and programs over the past six (6) years which were widely attended by local businesses. The following events were held in 1998:

Human Resource Network

A new initiative in 1998 was the development of the Fayette Human Resource Network. The network was formed as a cooperative effort between Fay-Penn Economic Development Council and the Central Fayette Chamber of Business and Industry. Business owners and managers are invited to a roundtable discussion on issues. The group of Human Resource Professionals and Managers holds quarterly meetings addressing topics such as insurance and benefits; recruiting and interviewing; workforce development; and legal concerns. The network is open to anyone concerned with the topics mentioned.

Tourism Development

In 1998, Fay-Penn worked diligently to assist in servicing \$50,000 through the Rivers of Steel/Pennsylvania Heritage Parks Program for the development of the Brownsville Wharf. In addition to funds raised in 1997, the effort will provide \$87,000 toward the completion of this project.

Distribution of the Fayette County Tourist Brochure began in 1998, with more than 40,000 copies handled out at 40 locations throughout the county. The brochure, describes everything from restaurants, to bed and breakfast establishments, to antique shops, to attractions, is designed to educate visitors about Fayette County's small business to increase the length of time visitors spend in Fayette County. By increasing the length of stay, economic impact is greatly enhanced.

Fay-Penn has also provided technical assistance to other local organizations for the planning and development of projects such as the Sheepskin Trail, the Heritage Trail, Touchstone Center for Crafts, the State Theatre for the Arts and Fort Necessity.

Pittsburgh Laurel Highlands - Regional Sign System Development

Planning for the Laurel Highlands Sign System was complted in 1998 and sign installation will begin in the summer of 1999.

Southwest Pennsylvania Railroad

On September 13, 1996, Fay-Penn acquired 24.9 miles of rail line



from CSX. Since that time, over \$730,000 in rehabilitation has been completed, including a \$334,000 rehabilitation project in 1998, that culminated in a realignment of track through Uniontown. In 1998, PennDOT approved a \$43,500 grant to assist in financing an additional \$58,000 in rehabilitation work to be completed by the end of 1999. The 65-mile, two county rail system, now known as the Southwest Pennsylvania Railroad, provides Fayette and Westmoreland County businesses with access to two class-one carriers --- CSX in Connellsville and Conrail in Greensburg. The pending sale

and division of Conrail system to CSX and Norfolk Southern will be an added benefit to users by expanding the rail system to include all of Norfolk Southern's track. This merger will effectively give Fayette County users access to three classone carriers, making rail freight shipping more cost effective. The



short line system will serve the Sony plant in Westmoreland County, the Fayette Business Park to the south, and a conglomerate of additional users in between. Rail service is currently offered five days per week in Fayette County.

contracted "Team PA" organization for Fayette County, Fay-Penn continued the business calling program initiated by Governor Tom Ridge in 1997. This initiative involves calling upon local businesses to assess their needs and provide direction to available services. The data collected in these interviews is reported to, and tracked by, the Commonwealth using state-of-the-art technology. In 1998, Fay-Penn's Business Development Coordinator met with 103 businesses, thirty (30) of which received services from Fay-Penn and other organizations through the "Team Pennsylvania" network.

Fayette Forward

Fayette Forward, in existence for the past four years, has been accomplishing its goal of maintaining an up-to-date, active Strategic Plan for Fayette County. A new printing of the Plan was published in 1998. The informal, community-driven organization started with a group of approximately 500 concerned citizens. Today, the level of involvement organization has grown to over 4000 people.

Since inception, Fayette Forward and the Fayette County Strategic Plan have been extended with the creation of two additional committees, i.e. Agriculture and Environment, and two community outreach centers located at the Uniontown Mall and Laurel Mall.

But, as with any strategic plan, there's no "resting on our laurels." The Strategic Plan is continually updated by rescanning the environment, identifying areas of need and opportunity, developing new responses for changing conditions, and documenting the progress-to- date.

Fayette Forward has used a community empowerment approach with the strategic planning process for years. The county residents must be involved in all stages of the process. Citizen participation gives ownership, responsibility, and accountability needed to make the programs successful.

The county-wide strategic plan also laid the ground work for the Federal Enterprise Community application that was successful in receiving the national designation.
