

CHAIRMAN'S MESSAGE

It is our distinct pleasure to present to you the Fay-Penn annual report for 2004. We invite you to read the report that describes the accomplishments and activities of the organization over the last year and the positive impact that they have had on Fayette County.

The cover theme of this report is devoted to downtown revitalization. The past year was very significant in that it saw the launching of a major downtown initiative for the county seat, the City of Uniontown. For decades, the City had been in slow decline resulting in deteriorated buildings and loss of economic activity. This trend of decline was suddenly reversed thanks to the efforts of many different people and organizations. Working with the City, we were able to capitalize on Governor Rendell's major stimulus program aimed at revitalizing small to mid-size towns across Pennsylvania. Thanks to the joint efforts of the state and federal legislative teams, we were able to secure approximately \$5 million in grants to help jump start the project. We were also successful in encouraging the Governor to release another \$2 million in the capital budget for the new business park along Route 40 in South Union Township.

It has been challenging for Uniontown to move from a level of minimal activity to such a large focused effort in such a short period of time. The public, non-profit and private sectors have had to work cooperative together at unprecedented levels. The primary objective of any community revitalization effort is to attract new private investment. This is where private developer, Joe Hardy, moved the project to an entirely new level of activity. We commend his efforts not only in making significant investments in renovating old buildings and recruiting new retail businesses, but for supporting numerous events to bring people and breathe new life into the downtown area.

We also commend the City of Uniontown for stepping up to support the effort by investing millions of dollars and working to expedite the project. Their actions have helped to set the tone for other communities demonstrating that we must be willing to invest in ourselves first if we expect to receive help from others.

While the focus has been primarily on Uniontown, we hope to see new downtown development moving to other communities in Fayette County as well. As we improve our communities, we improve our quality of life and the image of our county as a great place to live, work and play, which improves our ability to attract and retain businesses. And, Fay-Penn will continue to do whatever it can to support the continued growth and sustainability of our communities.

ORGANIZATION OVERVIEW

<u>Mission</u>

Fay-Penn's mission is to maintain andincrease employment opportunities(jobs) in Fayette County in an effort toimprove the quality of life for all of itsresidents. This mission is met througha comprehensive strategy of specificeconomic development objectives andby providing superior services to itsclients. The organization primarilyfocuses on the manufacturing sector inaddition to a concentration on tourismand infrastructure development. Theobjectives and strategies listed heresummarize initiatives in which Fay-Penn is involved.

Incorporated in 1991, Fay-Penn was formed to assist in the economic revitalization efforts of Fayette County. The organization was designated by the Internal Revenue Service (IRS) as a tax-exempt, nonprofit organization under Section 501(c)(3) of the Internal Revenue Code. As a membership based organization with 163 members, funding comes from various local, public, and private contributors and foundations, in addition to grant support from the Commonwealth of Pennsylvania and federal government for specific projects. Funds may not be used for the benefit of or be distributed to members, directors, officers, or private persons. All contributions are used to support the economic development revitalization efforts including providing administrative assistance for other economic development organizations and initiatives.

Build linkages with local, regional and state organizations, and the private business sector to develop the resources needed to implement a comprehensive tourism development strategy. Assist local government, businesses and community development organizations in their efforts to develop new tourism attractions and renovate downtown areas throughout Fayette County.
Provide services to ensure that Fayette County has a qualified workforce to accommodate world-class industry. Serve as a facilitator for companies and educators to coordinate educational and workforce development system services. Support the development of employer-driven workforce training programs. Establish educational initiatives that address the current needs of businesses.

Financing Assistance:

The staff works hands-on with each company guiding them through the necessary procedures and coordinating efforts with the company's private lending institution to access a variety of lowinterest financing programs available through the Pennsylvania Department of Community and Economic Development (DCED).

Business Technical Assistance:

Fay-Penn, with the support of a regional and state economic development team, under the "PA Business Retention & Expansion Program," offers technical assistance to businesses of all types and sizes. The staff will do whatever is possible to assist companies in meeting their business development needs, including financing, marketing, process improvement, government procurement, exporting, quality improvement, as well as other services.

Small Business Technical Assistance:

Fay-Penn's staff provides technical assistance to start-up and existing businesses. Service is provided on a private, individual basis in an effort to secure loan financing and to improve business success. The staff also participates in conducting small business seminars to ensure entrepreneurs an opportunity to keep abreast of the latest up-to-date small business issues.

Tourism Development:

Fay-Penn works with businesses, historical groups, and other agencies to develop the tourism industry in Fayette County beyond its already wonderful array of visitor-ready sites and attractions. Assisting to develop new businesses, attractions, community projects, and increasing tourism packaging efforts all help Fayette County's tourism industry grow.

Revolving Loan Fund:

Fay-Penn administers a \$11.4 million loan fund to assist qualified businesses with financing. Low interest loans of up to \$750,000 can be made. Specific guidelines have been developed and approved by the PA DCED to determine the project eligibility.

Site Selection:

Current listings of available sites or buildings are maintained by Fay-Penn and are provided to companies looking for new locations. The staff works closely with the PA Governor's Action Team and other economic development agencies on potential projects and networks with realtors and property owners to keep abreast of the industrial real estate market. Site proposals are customized with current market, workforce, utility and quality of life information.

Workforce and Education Assistance:

Fay-Penn's Workforce and Education Development initiative provides services to address both the short and long term workforce needs of local businesses. The staff also coordinates meetings for local companies with experts from other regional economic development organizations specializing in customized workforce training, ISO 9002 standards, Lean Manufacturing, and other world-class, guality training.

Business Park Development:

Working with the Fayette Industrial Fund. Connellsville Industrial Enterprises, the Fayette County Redevelopment Authority, and local municipal authorities, the Fay-Penn staff acquires and develops new land and infrastructure with special focus on industrial and business parks.

Fay-Penn offers a full range of confidential services and works closely with each client to provide customized service.



REVOLVING LOAN FUND

The year 2004 was another successful year for Fay-Penn's Revolving Loan Fund (RLF). Originally established in 1993, the RLF had grown from \$1 million to \$11.4 million at the end of 2004, thanks to grants secured through the Fayette County legislative delegation.

The RLF is comprised of seven separate programs that assist eligible businesses by funding capital expansion projects in fixed assets, such as new equipment and facilities at low interest rates.

Five projects received \$397,000 in financing assistance through the RLF in 2004. These projects generated additional private investment of \$985,780 and resulted in the creation and/or retention of 34 jobs.

To date, 97 projects have been financed involving over \$40 million in private investment and the potential creation and/or retention of 3,500 jobs.

In 2004, the United States Department of Agriculture (USDA) provided an additional \$300,000 to capitalize Fay-Penn's Downtown Revitalization Loan Fund (DRLF). The DRLF, established in 2003, was initially capitalized utilizing a \$75,000 grant through the PA Department of Community and Economic Development's New Communities Program. Fayette Capital Loan Fund (FCLF):The FCLF assists eligible businesses by funding capital expansion projects in fixed assets, such as new equipment and facilities at low interest rates. This program has provided assistance to 66 companies since its inception.

Loan Guarantee Program (LGP): The Loan Guarantee Program can guarantee a percentage of private lending institution loans to eligible companies. Since its inception, eight companies have utilized this program.

Tourism Revolving Loan Fund (TRLF): Established in 1998, the TRLF Program is designed to encourage tourism commerce development in Fayette County. To date, nine projects have been financed through this program resulting in the expected creation of 48 tourism-related jobs.

Enterprise Zone Loan Fund (EZLF): The EZLF was established with the support of the Fayette County Board of Commissioners and the state legislative delegation. Projects eligible to access these loan funds must be located within the designated Fayette County Enterprise Zone. To date, 14 projects have been financed through the program resulting in the creation and/or retention of 293 jobs.

Workforce Development Loan Fund (WDLF): In 2000, Fay-Penn established the new WDLF. This program assists educational facilities to expand existing or create new workforce training programs that address the needs of the private business sector. To date, two projects were funded under this program that will result in the training of 1,030 individuals.

Residential Development Loan Fund (RDLF): In 2002, Fay-Penn created the RDLF to encourage private sector investment in new residential housing developments to address the current and future needs of Fayette County residents. To date, one project was funded under this program resulting in the development of nine new residential lots.

Downtown Revitalization Loan Fund (DRLF): In 2003, Fay-Penn established the DRLF to help businesses to make investments in our downtown areas to promote growth, commerce and economic development. Fay-Penn will assist in financing retail and service business projects in a downtown business district. Eligible projects include building acquisition, equipment purchases, leasehold improvements, façade and building improvements and working capital.

REAL ESTATE

SITE DEVELOPMENT, BUILDING ACQUISITION AND MARKETING

In 2004, Fay-Penn completed development of the 193 acre University Technology Park, located adjacent to Penn State Fayette - Eberly Campus. Fay-Penn also acquired a 56,484 sq. ft. facility located in the Connellsville Industrial Park, Bullskin Township, formerly occupied by Tedesco Manufacturing. The building will be improved and marketed to companies interested in leasing space in the northern end of Fayette County. Fay-Penn continues to actively market available properties in Fayette County and helped to secure \$2 million in the state capital budget for the Fayette County Business Park located along Route 40 in South Union Township.

BUILDINGS AND BUSINESS DEVELOPMENT SITES

Fay-Penn owns, operates and maintains ten buildings, offering 347,844 sq. ft. of space to existing and potential tenants, and wth its sister organization, Fayette Industrial Fund, operates and maintains three business development sites totaling 660 acres, 465 of which are ready for immediate development. Fay-Penn also owns another 1,158 acres of land in three different locations for future development.

FAYETTE COUNTY ADVANCED TECHNOLOGY COMPANIES WORKING TO IMPROVE NATIONAL SECURITY

Several companies working to improve national security have located and/or started operations in Fayette County thanks to the support of Congressman John P. Murtha and the Governor's Action Team. Fay-Penn is pleased to have provided financial and/or location assistance to these companies in 2004. **ProLogic, Inc.,** a Fairmont, WV-based company, is an information technology provider and defense systems integrator, specializing in geospatial information systems (GIS), data visualization, knowledge management, system integration and business process re-engineering. The company is temporarily located in downtown Uniontown until such time as construction is complete on its 14,000 sq. ft. facility

ST PRODUCTION SYSTEMS began a new engineering

in the University Technology Park, currently under construction.

center operation at an existing 36,450 sq. ft. facility located on Route 119 North in North Union Township. A wholly-owned subsidiary of Newington, VA-based SenSyTech Inc., ST Production Systems' primary focus is support of the Navy's Surface Ship Torpedo Defense System, a torpedo countermeasure system.

TRIDENT TECHNOLOGY SOLUTIONS, a Fairfax, VA company, recently located a new operation in a 4,550 sq. ft. building located in the Greater Uniontown Business Park, owned by Fay-Penn. Trident's local office assembles, integrates and tests electronic devices for commercial and military applications and for commercial touch-screen integration. The company expects that more than 3,000

touch-screen units integrated at the Mount Braddock facility this year will be used in 911 call centers, medical applications, financial trading floors and factories. The office also integrates handheld command and control systems for the U.S. Marine Corps, including component testing, software integration and system testing, and produces small, specialized electronic devices for the U.S. Special Operations Forces.





UNITED FIRST RESPONDERS produces Anthrax sensors for the Department of Defense and Homeland Security. The company is located in approximately 7,000 sq. ft. of Fay-Penn's multi-tenant facility located in the University Technology Park.

ADVANCED ACOUSTIC CONCEPTS (AAC), a

Hauppauge NY-based company, is the design agent for the Tripwire Sensor Processor System for the Surface Ship Torpedo Defense Program. In early 2005, the company moved into a 40,000 sq. ft., \$3.1+ million facility located in the University Technology Park, owned by Fay-Penn. The local company produces, integrates and tests the systems for every Navy surface ship.



GENE AND BOOTS CANDIES, INC.

Gene and Boots Candies, located in Star Junction, PA is undertaking a \$225,000 expansion project with the assistance of a \$112,500 loan from Fay-Penn's Revolving Loan Fund. The company is renovating its facility and expanding its product line. The loan

proceeds will be used for equipment, machinery, and building renovations necessary to facilitate the manufacturing of ice cream.



CLARKE IRON & METAL, INC.

Fay-Penn assisted Clark Iron & Metal, Inc., based in Adah, PA, by providing a \$71,500 loan through its Revolving Loan Fund to assist in acquiring a new piece of machinery. The company engages in the scrap metal business by processing and removal of scrap metal, which is sold to mills to be recycled. The new machinery will permit the company to crush and bale its scrap metal in-house to enable it to be more productive and increase revenues.

WOODLAND ZOO

A \$50,000 loan from Fay-Penn's Revolving Loan Fund will be used to support an \$850,000 expansion project by Woodland Zoo, located in Farmington, PA. Along with the purchase of the land on Route 40 the Woodland Zoo loan proceeds will be used to build animal enclosures



and site prep, purchase equipment and fixtures, and renovation. This attraction venue would have the capability of attracting 100,000 to 150,000 visitors a year.

SPECIALTY CONDUIT & MANUFACTURING

Fay-Penn approved a \$80,000 loan from its Revolving Loan Fund to support a \$178,780 expansion by Specialty Conduit located in the Greater Uniontown Business Park, Mt. Braddock, PA. The loan proceeds will be used to assist in purchasing new machinery to convert steel tubing into threaded pipe.

MF&B RESTAURANT SYSTEMS, INC.

MF&B, currently located in the Connellsville Incubator, remanufactures conveyor pizza ovens for companies like Fox's Pizza, Pizza Hut and Domino's. The company is undertaking a \$250,000 expansion project which includes the acquisition and renovation of a commercial site in Dunbar, PA and the purchase of additional machinery and

equipment. Fay-Penn approved a \$83,000 loan from its Revolving Loan Fund to assist in financing this expansion project.



SUBWAY RESTAURANTS

A new Subway franchise is leasing 1,200 sq. ft. in Fay-Penn's multi-tenant facility, located in Redstone Township. The Subway chain has been rated the #1 franchise opportunity by *Entrepreneur'* magazine for 12 of the past 16 years. Subway has over 21,629 locations in 76 countries, including over 17,300 locations in the United States

SMALL BUSINESS DEVELOPMENT

Fay-Penn's Small Business Development Program answered 164 inquiries during 2004. Twenty-six individuals or businesses received technical assistance, with four businesses securing \$1,034,000 in financing, resulting in the creation and/or retention of 53 jobs. Continuing to be responsive to the needs of small business,

Fay-Penn works with the Service Corp of Retired Executives (SCORE) and the St. Vincent College - Small Business Development Centers.



SBA MICROLOAN

The Small Business Administration Microloan Program continues to provide an alternative source of financing to small business owners. The program was established in 1993 as a cooperative effort among Fay-Penn Economic Development Council, Greene County, and Washington County Council on Economic Development, the program administrator. Since then, the Economic Growth Connection of Westmoreland, the Morgantown Area Economic Partnership, and the Monongalia County Development Authority have joined the effort. To date, 23 Fayette County businesses have been assisted by the program with financing totaling \$512,020.




Fay-Penn met with 75 local businesses to assess their current and future needs

and provide assistance to 26 of those companies under the PA Business Retention and Expansion Program. Partnering with the Workforce Investment Board (WIB), Fay-Penn met with ten companies to market and promote job training, workforce and job placement services, resulting in 24 job placements and eight companies being awarded \$159,200 in worker training funding for 316 workers.

FAYETTE FORWARD

Fay-Penn provides administrative support for this public-private partnership of government and public agencies, non-profit organizations, private sector businesses and professionals, and other civic-minded citizens who came together in 1994 to



initiate strategies for positive change in Fayette County. Updated in 2003, the Fayette County Strategic Plan recieved an award recognition in 2004 by the Pennsylvania Planning Association.

SOUTHWEST PENNSYLVANIA RAILROAD

Fay-Penn, through its affiliate organization, the Fay-Penn Industrial Development Corporation (IDC), continues to own and oversee the

operation of 27 miles of rail line through Fayette County. The rail line provides rail service to seven Fayette companies.



FAYETTE COUNTY STATE ENTERPRISE ZONE

Established in 1996, the Fayette County Enterprise Zone Program, operated by the Pennsylvania Department of Community and Economic Development, continues to make significant contributions to the county's economic development. Administered by Fay-Penn with support from the Fayette County Commissioners, the Enterprise Zone begins along the northern county border and extends southward through Smithfield Borough, following the Route 119/rail corridor. In 2004, through its Revolving Loan Fund, Fay-Penn disbursed \$306,625 in Enterprise Zone



funding. Funds received through the State Enterprise Zone Program and Ioaned through Fay-Penn's Revolving Loan Fund exceed \$1.7 million.

FAYETTE ENTERPRISE COMMUNITY (FEC)

The FEC Strategic Plan includes 98 benchmark activities totaling more than \$180 million dollars targeted at local revitalization efforts in the county's most distressed communities. Of the 98 benchmarks, 10 have been completed, 78 are in progress, and the remainder are inactive. At this time, a total of \$185.1 million in funds have been requested for the 98 benchmarks from various private, local, state and federal funding sources and \$75.4 million has been received. The United

States Congress appropriated \$215,200 for the FEC in 2004. The following received funding from the 2004 allocation to fund 11 FEC benchmarks:

Designated in 1999, the FEC, administered by Fay-Penn, covers 84.37 square miles of Fayette County including Redstone and Menallen Townships, certain census tracts in the cities of Uniontown and Connellsville, a portion of Dunbar Township, and three developable sites totaling 1,500 acres, i.e. Springhill Township Site, the Connellsville Airport in Dunbar Township, and the Fayette County Route 40 Business Park in South Union Township.

TOURISM DEVELOPMENT

In 2002, Fay-Penn commenced a tourism development project to the study the feasibility



of creating a regional cable tourism channel. The findings from the study resulted in the creation of "DISCOVER PITTSBURGH COUNTRY" that showcases the tourism and cultural opportunities in the 11-county region of southwestern Pennsylvania to visitors to the region's hotels and motels, as well as local residents within the region. Programming was launched in the fall of 2004 with funding for this phase of the project provided by a Pennsylvania Department of Community and Economic Development, Regional Marketing Initiative Grant of \$100,000 for the 2003-2004 program year along with other private foundation funding. It provides an affordable promotional vehicle for tourism venues and the small businesses that support them by promoting an area as a tourist destination and allowing communities to pull resources for mini-documentaries that include many local attractions. Presently the program can be accessed on post-gazette.com that attracts more than 2.4 million unique users for an average month and via Comcast Video on Demand service in the "Our Town" folder that is digitally connected to 343,000 households reaching a potential of 776,600 viewers. Upon full implementation, the program will be distributed digitally to approximately 775,000 households and over 1.4 million potential viewers in southwestern Pennsylvania by Comcast and other regional cable providers.

In 2004, Fay-Penn continued its efforts to establish a **TOURIST TRAIN** in Fayette



County. The importance of the project is to create an attraction that will bring tourists and local residents into the downtown Uniontown area on weekends. Fay-Penn is working with local businessmen and the City of Uniontown to establish an excursion train to enhance the downtown revitalization efforts.

DOWNTOWN UNIONTOWN REVITALIZATION

The City of Uniontown's downtown revitalization efforts began in the early 1990s, when Fay-Penn founder, Mr. Robert E. Eberly, and The Eberly Foundation began investing millions of dollars to improve the greater Uniontown community by making significant financial contributions to several public, private and non-profit organizations to implement numerous projects to improve the downtown Uniontown area. The photos on this page highlight some of the improvements funded with the support of Mr. Eberly and The Eberly Foundation.

In 2002, working with numerous local agencies, business owners and elected officials, Fay-Penn led the effort to move the revitalization project forward by developing a Uniontown Revitalization Comprehensive Strategy that resulted in an eleven-point plan that would position the downtown area for potential economic growth.

In April 2004, this project received a significant boost with the annoucements of millions of additional dollars in investments from both the public and private sectors. Thanks to the efforts of Governor Ed Rendell, Senator Richard A. Kasunic, Congressman John P. Murtha, our state repesentatives, the City of Uniontown, the Fayette County Commissioners, and Mr. Joe Hardy, approximately \$10 million more has been invested and/or committed to this effort resulting in several of those eleven strategies being implemented. Fay-Penn congratulates private developer, Joe Hardy, for his willingness to invest millions of dollars into the project and bringing new retail businesses into the downtown area.

Improvements to be made as a result of this funding include, but is not limited to: the construction of a new parking garage; renovations of the State Theatre Center for the Arts; streetscape improvements; building acquisition, renovation and/or demolition; elimination of blight; building facade improvements; construction of new public parks; conducting street fairs and activities; development of a master plan for city parks; establishment of parking along Main Street; etc.

The City of Uniontown's mayor and council members have shown great leadership in supporting this project. In addition to their support during this "whirlwind" revitalization effort, the City has agreed to accept the responsibility of serving as the official applicant to access million of dollars in state and federal grant funds and provide additional matching funds where necessary.

Fay-Penn has been designated by the City to serve as the administering agency on its behalf to assist in planning, implementation and administering the downtown Uniontown revitalization project. During 2004, Fay-Penn has played a significant role in the downtown Uniontown revitalization process and will continue to do so over the next several years. A highlight of Fay-Penn's activities and involvement since April 2004 include, but is not limited to: Assisting in the development of "The Uniontown Downtown Blueprint 2004" that outlines a course of action that will assist in enabling Downtown Uniontown to reach the locally-defined vision; providing staff and technical support to public and private entities; planning, preparing and/ or submitting five grant applications to four different funding sources for approximately \$5.7 million in funding; planning and designing for a new parking garage; creation of "free-parking" along Main Street, etc.

A superior education will create a better skilled workforce, which in turn will attract new residents and businesses to the area. REACH strives to provide local youth with the hope, opportunity and empowerment that quality education affords. REACH (and its business partners) works closely with the six public school districts in Fayette County on district-specific as well as county-wide initiatives.

SUMMARY OF REACH EFFORTS IN 2004

Business Partnerships: REACH worked diligently to expand its existing partnerships and to cultivate new collaborations with local businesses. These special partners contribute time, expertise, financial contributions (more than \$40,000 in 2004), as well as in-kind support, to various projects.

WorkKeys® (Product of Key2Work): WorkKeys® is a comprehensive career exploration program used in all our county schools that enables students to identify their career goals and the skills needed to achieve their goals. WorkKeys benefits employers when they "profile" a position for which students can assess their eligibility. Profiling helps businesses cut the cost of recruiting and selection, decreasing operational expenses such as turnover, training time, overtime, and downtime.

Education Partnerships: Once again, professional development training was provided for teachers in partnership with the International Center for Leadership Education (ICLE) in the areas of rigor and relevance, reading and writing in the content area, technical education, and character education. REACH also sponsored a group of educators to attend ICLE's Annual Model Schools Conference at which educators learned about best practices from throughout the nation. In turn, they brought back new ideas and initiatives to implement at the local level.

Innovative Collaborations: Understanding the importance of parental roles in school success, REACH became a partner with Good Schools PA-a statewide advocacy organization-as one of only five pilot sites for its Parent and Community Leadership Institute. Selected parents were trained as advocates for education. They will work closely with schools on projects specific to improving student achievement.

Project Implementation and Support: The National Academy Foundation "school within a school" program at Laurel Highlands High School launched the first year of its Finance and Hospitality/Tourism Academies.
